# **P** – **EBT** Overview



### What is P-EBT?

Pandemic EBT or P-EBT is part of The Families First Coronavirus Response Act, H.R. 6201.

### Who is eligible?

The P-EBT program provides additional food support for students who would have received **free and reduced-price meals** if not for the school closures due to COVID-19.



### Who is on free/reduced price meals?

### **Income guidelines:**

Children in households with incomes between 130 to 185 percent of the federal poverty level (FPL) are **eligible** for **reduced**-price **school meals**.

### **Eligibility:**

- Direct Certification
- Paper applications
- Community Eligibility Provision (CEP)\*

\*Not all students are subject to above income guidelines.



### **Massachusetts Waiver:**

MA was approved by FNS to start the implementation of Pandemic-EBT (P-EBT) on April 17, 2020.

### Included in the waiver:

- Provide benefits to both SNAP and non-SNAP households
- Total days for MA school closures 70 days
- Amount of \$5.70 per child per day



# Implementation

## **Identification:**

For implementation, DTA is managing the distribution of P-EBT into two distinct groups:

### • DTA Clients

Includes families with children who are currently **actively** receiving benefits from the Department

### • Non-DTA Clients

Includes families with children not active on benefits with the Department



## **DTA Clients:**

How much will I receive in benefits?

\$5.70 per student per day of school closure

How will I be notified?

Client notice and text message to grantee



Department of Transitional Assistance How many P-EBT households currently receive SNAP???

40% are children in a current DTA household. These households will get their P-EBT benefits on their existing EBT card in **April** & **May** 

## **Non- DTA Clients:**

How much will I receive in benefits?

\$5.70 per student per day of school closure

How will I be notified?

Client notice and a **P-EBT** trifold flyer.

How many P-EBT households currently are not on SNAP?

60% are children not in a DTA household. These households will get their benefits on a P-EBT Card.

One P-EBT card per eligible child/student.

**Pandemic-Electronic Benefits Transfer (P-EBT)** is additional food support for families during the COVID-19 pandemic.

Families will receive **\$5.70** per child per day for every day school is closed.

Cards will be mailed in **May**

Who will get a P-EBT card? ¿Quiénes recibirán una tarjeta P-EBT?



All Massachusetts families with school aged children who qualify for free or reduced price meals.

Todas las familias de Massachusetts con hijos en edad escolar que califiquen para comidas gratuitas o a precio reducido.



P-EBT benefits are available to households regardless of immigration status and are not considered in a public charge test.

Los beneficios de P-EBT están disponibles para grupos familiares independientemente del estado migratorio y no se consideran en una prueba de cargos públicos.

### One card per child will be provided for families not receiving DTA benefits.



## **P-EBT Client Notice**



### P-EBT PIN instructions on the notice



Department of Transitional Assistance Your child, Sally Jones, is approved to receive \$399.00 in P-EBT benefits for the total school closure period. Your child's P-EBT benefits will be loaded onto a new EBT card in **two payments**, one in May and one in June. The EBT card will be mailed to you in a separate envelope.


You will need the **last 4 digits of your child's case number** (provided above) and your child's **date of birth** to create a PIN for the EBT card. <u>Note</u>: If you have more than one child in your household, you will receive a separate EBT card for each eligible child.

## **P-EBT Card Set up**

To PIN the new P-EBT card:

- Call the number on the back of the card – 800-997-2555
- Select Option 2
- Create a PIN using the last 4 digits of your child's case number provided on the notice and the child's date of birth (using the 2 digit month + 2 digit day: Example: 04/06=0406)





# **Using the P-EBT Card**

- Receipt of P-EBT does not confer SNAP eligibility.
- P-EBT cannot be used to access HIP benefits.
- P-EBT card holders will not have access to DTA Connect
- To check their balance, they can call the # on the back of the card.



• What if a child gets free breakfast and lunch, but their family does not receive SNAP?

DTA will be working with the Department of Elementary and Secondary Education (DESE) and our partners at The Shah Family Foundation and Project Bread to reach these households.

Will receipt of P-EBT confer Public Charge?
 P-EBT is not considered a public benefit under the public charge policy. Receiving nutrition assistance through P-EBT would not make an immigrant a "public charge."



### • Can families apply for P-EBT?

There is no application for the P-EBT benefit, families qualify for the benefit by applying for SNAP or the NSLP or by being part of a CEP (Community Eligibility Provision) school.

Will the materials be translated?

All information is in English and Spanish, and we are looking into translating into Portuguese, Chinese, Haitian Creole and Arabic as well.



• Families who were not signed up for free and reduced lunch at close of school but would now qualify because parents are currently out of work, can they still apply?

Those families are encouraged to apply for SNAP because we have no confirmation on the capacity of schools to complete school meal applications at this time.

 If applying for SNAP or school lunch now, how much will I get in P-EBT benefits?

FNS requires that families who become eligible after school closures be issued prorated P-EBT benefits. DTA will apply the proration after initial issuances to all currently active/eligible families.

 What if I have moved, I have not notified my child's school and did not get my notice or P-EBT card?
 Contact Project Bread FoodSource Hotline at 1-800-645-8333
 and provide your child's student ID#. They will notify DTA.



### • What if I do not want the P-EBT card?

If your family does not want/need to use the benefits issued on their P-EBT card, they can destroy the card. The benefits are subject to SNAP expungement rules, if the card is not used in 365 days, the benefits will be removed.

• Will I get a another card when I get additional P-EBT benefits?

Families **need to keep their P-EBT** card because a second issuance will be made on the same card. A new card is not mailed each time P-EBT benefits are issued to the family.



• Can families still access the grab-n-go lunches at the schools ?

Yes, families can participate in both programs.

If a family does not have an active SNAP case, will the benefits still go on the EBT card?
 No, at initial issuance benefits will be paid to active DTA clients. If they are receiving NSLP, benefits will issued on the P-EBT card.



- Can students in private schools also receive P-EBT? Yes, about 34 private schools also have free/reduced price meals.
- If the family is only receiving cash assistance, can they still get P-EBT?

Yes, they will receive P-EBT as long as they are determined to be receiving or are eligible for free or reduced price meals based on the DESE list.

• What if you are an undocumented minor, living alone? They can also receive a P-EBT card as long as they are determined to be receiving or are eligible for free or reduced price meals based on the DESE list.
