**The following rules will be implemented for the safety of all attendees and must be followed without exception:**

- **Students must arrive between 6:00 - 6:30 PM.**
- This form must be filled out for everyone in attendance to be admitted into the building.
- All school rules will apply.
- No outside food or beverages are permitted.
- Any violation involving criminal behavior will be handled accordingly
- Once a student leaves the West Chop Beach Club, they will not be able to return to the Gala.

**Accident Waiver and Release of Liability:** *(Every student and their date must sign and submit this release for to be eligible to participate in the Gala)*

I acknowledge that attendance at MVPCS Gala is an event that involves risk. I hereby assume all risk associated with my or my child's participation in this event. I acknowledge that this Accident Waiver and Release of Liability form will be used by MVPCS and will govern my actions and responsibilities at this event.

**Assumption of Risk** - The parent/guardian and student assume any and all risks, known or unknown, which may exist as a result of the student's participation in the Gala, including, but not limited to traveling to the Gala, attendance and participation at the Gala and traveling from the Gala.

**Release of Organizers** - The parent/guardian and student voluntarily and expressly release and forever discharge MVPCS from any and all liability, claims, damages, demands, or personal injuries which arise from or are in any way connected to the student's participation in the Gala, including those allegedly attributable to negligent, reckless, or grossly negligent acts or omissions of MVPCS.

**Obligation to Obey Organizers** - The parents and students shall abide by and obey all instructions given by MVPCS staff with respect to the students' participation in the Gala. The parent and student understand that if the student does not comply with instructions given by MVPCS staff, the school has the right to remove the student from the event, and notify the parent via phone of the student's dismissal.

The parent and student acknowledge that they had sufficient opportunity to read this entire waiver. The parent and student fully understand the content of this document and agree to abide by its terms
