**The following rules will be implemented for the safety of all attendees and must be followed without exception:**

- **Students must arrive between 5-5:30 pm.**
- **This form must be filled out for any Guests in attendance to be admitted into the tent/building.**
- All school rules will apply.
- No outside food or beverages are permitted.
- Any violation involving criminal behavior will be handled accordingly
- Once a student leaves the school grounds, they will not be able to return.

**Accident Waiver and Release of Liability:**

I acknowledge that attendance at MVPCS True Colors Ball is an event that involves risk. I hereby assume all risk associated with my or my child's participation in this event. I acknowledge that this Accident Waiver and Release of Liability form will be used by MVPCS and will govern my actions and responsibilities at this event.

**Assumption of Risk** - The parent/guardian and student assume any and all risks, known or unknown, which may exist as a result of the student's participation in the True Colors Ball, including, but not limited to traveling to the ball, attendance and participation at ball and traveling from the ball.

**Release of Organizers** - The parent/guardian and student voluntarily and expressly release and forever discharge MVPCS from any and all liability, claims, damages, demands, or personal injuries which arise from or are in any way connected to the student's participation in the ball, including those allegedly attributable to negligent, reckless, or grossly negligent acts or omissions of MVPCS.

**Obligation to Obey Organizers** - The parents and students shall abide by and obey all instructions given by MVPCS staff with respect to the student's participation in the ball. The parent and student understands that if the student does not comply with instructions given by MVPCS staff, the school has the right to remove the student from the event, and notify the parent via phone of the student's dismissal.
